Publication of the Invitation to Bid	The BAC Secretariat said that the Invitation to Bid (ITB) was posted at the Philippine Government Electronic Procurement System (PhilGEPS) website, TESDA website and on the Bulletin Board near the TESDA Entrance at Gate 1 which is the place reserved for the posting of notices and information on procurement activities last June 7, 2019.
