RESOLUTION NO. 2001- 06

**PRIORITIZATION OF THE TWENTY NINE (29) OCCUPATIONS
RECOGNIZED UNDER THE TESDA OCCUPATION
QUALIFICATION AND CERTIFICATION SYSTEM (TOQCS)**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;


WHEREAS, during the 32ND TESDA Board Meeting, 06 July 2001, the Board agreed to focus its efforts and resources on the twenty nine (29) occupations recognized under the TOQCS namely: Seafarer Deck Rating and Seafarer Engine Rating under the Maritime Sector; Carpenter, Plumber - Building Construction, General Mason, Building Wiring Electrician, Heavy Equipment Mechanic and Heavy Equipment Technician (Operator) for the Construction Sector; Computer Service Technician for the Information Technology Sector; Machinist and Welder under Metals & Engineering Sector; Driver, Auto Mechanic, Small Engine Mechanic, Automobile Body Repairer/Finisher and Engine Rebuilder for the Automotive/Land Transport Sector; Refrigeration/Air-Conditioning (RAC) Service Technician for Heating/Ventilation/Air-Conditioning-Refrigeration (HVAC-R) Sector; Aquaculturist, Horticulturist and Integrated Farm Operator for Agriculture and Fishery Sector; Dressmaker and Tailor for the Garments Sector; Cook, Food and Beverage Service Attendant, Travel Officer and Housekeeping/Room Attendant under the Tourism Sector; the Security Specialist and Health Caregiver for Health, Social and Other Community Development Services Sector and the Shoemaker for Footwear Industry Sector;

WHEREAS, existing training regulations previously approved and promulgated by the TESDA Board are still listed and are available at the TESDA Secretariat for implementation;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board approves the twenty nine (29) occupations recognized under TOQCS and hereby directs the Secretariat in the development of training regulations and skills standards and tests for its immediate implementation;

BE IT RESOLVED FINALLY, that copies of this resolution, be furnished concerned agencies for their information and participation in support of these training regulations, standards and tests.
