RESOLUTION NO. 2002- 03

APPROVING THE EXTENSION OF THE CONTRACT WITH CHEVRON SECURITY
AND INVESTIGATION AGENCY, INC. FOR SECURITY SERVICES AND EMPOWERING
THE CHAIR OF THE TESDA BOARD TO SIGN THE CONTRACT

WHEREAS, Section 8, paragraph 3 of Republic Act 7796 entitled Technical Education and Skills Development Act of 1994, states that "the Board has the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing laws, rules and regulations;

WHEREAS, the Board, consistent with their resolution that activities undertaken by the Technical Education and Skills Development Authority (TESDA) covered by the approved Work and Financial Plan are deemed approved without further need of a board deliberation as agreed during the 31st TESDA Board Meeting last 14 December 2000;

WHEREAS, during the 8th Finance Committee-TESDA Board Meeting held last 18 February 2002 it recommends the extension of TESDA's contract with Chevron Security and Investigation Agency, Inc. for the security services requirement of the Technical Education and Skills Development Authority since the original contract was only for five months in 2001 as a result of the public bidding conducted on January 2001 and on the basis of good performance of the agency;

WHEREAS, during the above stated Board Meeting, the Committee agreed that the needed security services is part of the TESDA Work and Financial Plan Y2002, which will be approved by the TESDA Board;


NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board approves the extension of the contract with Chevron Security and Investigation Agency, Inc. to provide the security services needed by the Central Office of TESDA for seven (7) months from January 2002-July 2002;

BE IT RESOLVED, FINALLY, that the Board authorizes the Chairman of the TESDA Board to enter and sign the extension of the contract of service in favor of Chevron Security and Investigation Agency, Inc., for and in behalf of the Board.
