RESOLUTION NO. 2002- 07

ADOPTION AND PROMULGATION OF THE REFORMULATED
TESDA VISION, MISSION AND VALUES STATEMENT

WHEREAS, during the TESDA Board Strategic Planning Workshop held at the Development Academy of the Philippines, Tagaytay City last Feb. 1-2, 2002, a Committee on the Revision of the Vision, Mission and Values Statement of TESDA was created to finalize the vision, mission and values statement;

WHEREAS, during the 34th TESDA Board Meeting, 21 February 2002 held at the TESDA Board Room, 7/F Admin. Building, Taguig, Metro Manila, the Committee on Vision, Mission and Values Statement favorably endorsed to the Board the proposed reformulated vision, mission and values statement for their approval;

WHEREAS, the Board approved the proposed reformulated vision, mission and values statement as follows:

Mission

TESDA provides direction, policies, programs, and standards towards quality technical education and skills development.


Values Statement

We believe in demonstrated competence, institutional integrity, personal commitment and deep sense of nationalism.


