FROM P300.00 TO P200.00


WHEREAS, Section 8, paragraph 9 of the Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to exact reasonable fees and charges for such tests and trainings conducted and retain such earnings for its own use, subject to the guidelines promulgated by the Authority;

WHEREAS, during the 26<sup>th</sup> Executive Committee - TESDA Board Meeting held on 19 September 2002, the members of the Executive Committee - TESDA Board favorably endorsed the approval of the decrease of the maritime portfolio assessment fee from P300.00 to P200.00 being charged by the TESDA Accredited Assessment Centers;


WHEREAS, the reduction in the portfolio assessment fee was based on the request of the Maritime Training Council (MTC) to harmonize the TESDA assessment fees with the fees being charged by the National Assessment Center (NAC) of the MTC which is P200.00 while the assessment centers of TESDA are charging P300.00 for portfolio assessment.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board approves the decrease in the maritime portfolio assessment fee being charged by the TESDA Accredited Assessment Centers from P300.00 to P200.00


