Resolution No. 2003 - 30

Approving the Awards of the Contracts for Security and Janitorial Services in Favor of Envisage Security Agency Incorporated and Superclean Services Corporation Respectively for CY 2004, Effective January to December 2004

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing laws, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Bids and Awards Committee (BAC) of the Secretariat has recommended to the Director General through Resolutions No. 20 and 21 the award of contracts to Envisage Security Agency, Inc. and Superclean Services Corp. respectively in consonance with RA 9184 or the "Government Procurement Reform Act" and its Implementing Rules and Regulations;

WHEREAS, the designated Officer-In-Charge of TESDA, having been vested such authority, has approved the BAC Resolutions and recommended their approval to the TESDA Board Finance Committee;

WHEREAS, the following documents have been appended in the BAC Resolutions to be read as an integral part of BAC Resolution No. 20 (Security Services) and BAC Resolution 21 (Janitorial Services);




