Directing the Bids and Awards Committee (BAC) of TESDA to Adopt and Implement Pre-qualification and/or Eligibility Checking for Domestic and Foreign Assisted Projects (FAPs) Procurement in addition to the Provisions of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, its Implementing Rules and Regulations and other relevant rules and regulations

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, in the Second Foreign Assisted Projects (FAPs) Committee Meeting of the TESDA Board held on 14 November 2003 and the 11th RGAU Committee Meeting held on 21 November 2003, the Committees have recommended henceforth, to pre-qualify bidders during the procurement of goods and services, both foreign and domestically funded in addition to the requirements provided in RA 9184 other known as the "Government Procurement Reform Act" and its Implementing Rules and Regulations;

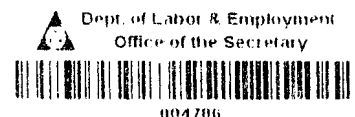
BE IT RESOLVED FINALLY, that copies of this resolution including all necessary documents be disseminated to all concerned.
