**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR
CABLE TV INSTALLATION NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 55th TESDA Board Meeting which was held last 20 April, 2007, the TESDA Board considered and approved Board Resolution No. 2007-11 on the prioritization of thirty five (35) titles for training regulations development for year 2007 where Antennas/CATV Installation was included;

WHEREAS, the concerned industry association, the Philippine Cable TV Association (PCTA) has endorsed for promulgation the Training Regulation for Cable TV Installation NCII;

WHEREAS, in the 26th Standard Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting held last 14 November, 2007 the Training Regulation for Cable TV Installation NCII was deliberated upon and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, during the 53rd EXCOM-TESDA Board Meeting held on 19 November, 2007 the EXCOM-TESDA Board endorsed favorably the aforementioned Training Regulation for consideration and approval by the TESDA Board;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 22 November, 2007 approves the Training Regulation for Cable TV Installation NCII.




**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR
