WHEREAS, Board Resolution No. 2008 – 17 Prioritized Automotive Servicing (LPG Engine Conversion) Qualification Title for Y 2008 Training Regulations Development;

WHEREAS, Board Resolution No. 2006 – 09 Approved and Promulgated the Training Regulation for Automotive Servicing NC III;

WHEREAS, during the 35TH Standards Setting and Systems Development (SSSD) TESDA Board – TESDA Secretariat Consultation Meeting held on 03 October 2008; 10:00 p.m. it was agreed that the Training Regulations for Automotive Servicing NC III be amended to include the units of competencies:

- 1) Install LPG Conversion Kit
- 2) Test and Adjust LPG Calibration
- 3) Service LPG System
- 4) Remove and Replace Automotive Engine and Engine-related Systems for automotive vehicles using Liquefied Petroleum Gas




**APPROVING THE AMENDMENTS ON THE TRAINING REGULATIONS FOR
AUTOMOTIVE SERVICING NC III TO INCLUDE LPG ENGINE RETROFITTING
AND REPOWERING**
