**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR
CAREGIVING (INSTITUTIONAL) NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, to support and address the urgency of supplying demand for workers by employers both in the local and overseas market for Caregiving (Institutional) NCII, there is a need to prioritize the aforementioned training regulation;

WHEREAS, during the 40th Standards Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting on 11 May 2009, the body recommended the inclusion of Institutional Caregiving NCII as one of the priority qualifications for Year 2009;

WHEREAS, in the 40th Standards Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting on 11 May 2009, the aforementioned qualification title was deliberated and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 67th EXCOM-TESDA Board Meeting on 06 July 2009; 1:00 p.m. the EXCOM-TESDA Board has endorsed favorably the aforementioned qualification title for consideration and approval of the TESDA Board;

WHEREAS, in the 70th TESDA Board Meeting on 13 July 2009; 2:00 p.m. the TESDA Board considered and approved the prioritization of the aforementioned qualification title for training regulations development for Year 2009;

WHEREAS, in the 68th EXCOM-TESDA Board Meeting on 21 October 2009, the EXCOM-TESDA Board endorsed favorably the aforementioned training regulation for consideration and approval of the TESDA Board;

WHEREAS, in the 71st TESDA Board Meeting on 21 October 2009, the TESDA Board considered and approved the Training Regulation for Caregiving (Institutional) NCII.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 13 July 2009; 2:00 p.m. approves the Training Regulation for Caregiving (Institutional) NCII.

BE IT RESOLVED FINALLY, that copies of this Resolution and Training Regulation be published and disseminated to all concerned, and shall be effective fifteen (15) days upon its publication. All programs registered under or to be under this training regulation must comply with the requirements of the aforementioned training regulation. Graduates of TVET courses covered by the aforementioned training regulation shall be required to undergo mandatory assessment under the national assessment and certification program.




