**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
GARBAGE COLLECTION NC I**

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country.

WHEREAS, concerns relating to environmental protection and sustainability has led to more emphasis in the area of solid-waste management;

WHEREAS, the Ecological Solid Waste Management Act of 2000 (Republic Act No. 9003) calls for, among others, skills development along the various areas of collection, transport and dumping of garbage particularly municipal/city waste;

WHEREAS, in the 15th Direction Setting (DS) Committee-TESDA Board-TESDA Secretariat Consultation Meeting on 11 December 2012, the TESDA Board approved the prioritization for training regulations development of qualifications along solid-waste management, which includes the job of Palero;

WHEREAS, industry experts and partners, headed by Ms. Lizette C. Cardenas of the Solid Waste Management Association of the Philippines (SWAPP), Mr. Crispian N. Lao of the National Solid Waste Management Commission (NSWMC-DENR), Ms. Isabelita P. Mercado of the Solid Waste Contractors' Association of the Philippines (SWACAP) and other organizations involved in garbage collection and sanitary landfill operations with the assistance of the Qualifications and Standards Office (QSO) of TESDA, have developed and endorsed the same for TESDA Board approval;

WHEREAS, during the 77th Standards-Setting and Systems Development (SSSD) Committee – TESDA Board-TESDA Secretariat Consultation Meeting held on 28 January 2015, the Committee favorably endorsed the promulgation of the abovementioned Training Regulations for Garbage Collection NC I;


**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR



BE IT RESOLVED, FINALLY, that copies of this Resolution and the abovementioned Training Regulations be published and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication. All programs registered under these Training Regulations must comply with the requirements of the aforementioned Training Regulations. Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.
