APPROVING THE AMENDMENTS TO THE TRAINING REGULATIONS FOR DOMESTIC WORK NCII THEREBY DELETING THE PROVISION ON ONE (1) MONTH GAP PRIOR TO THE REASSESSMENT OF CANDIDATES WHO INITIALLY FAILED IN THE COMPETENCY ASSESSMENT AND IMPOSING THE MANDATORY REFRESHER COURSE FOR THOSE WHO HAVE FAILED THE ASSESSMENT TWICE

WHEREAS, TESDA Board Resolution No. 2014-08 was issued approving and promulgating the Training Regulations (TR) for Domestic Work NC II last 1 October 2014 during the 89th TESDA Board Meeting;

WHEREAS, it is the policy of the TESDA to review any Training Regulations (TR) promulgated by the TESDA Board to cater to changes brought about in the industry without waiting for the three (3) year period;

WHEREAS, there was a series of consultation meetings with stakeholders and agreed to delete the one (1) month provision in the training regulations in the re-assessment of candidates who failed in the competency assessment (Section 4 Assessment and Certification Arrangements item 4.5) to wit:

“Reassessment is allowed only after one month from the date of assessment”.

WHEREAS, the TESDA Board 91st Standards-Setting and Systems Development (SSSD) Committee meeting on 7 December 2016 reiterated the provision on Section 4, item 4.6 of the above-mentioned TR on re-assessment of candidates, to wit:

“A candidate who fails the assessment for two (2) consecutive times will be required to go through a refresher course before taking another assessment.”
