APPROVING THE AWARD OF CONTRACT TO D' TRIUMPH CLEANERS AND  
ALLIED SERVICES, INC. FOR THE PROVISION OF JANITORIAL SERVICES  
REQUIREMENTS FOR TESDA CENTRAL OFFICE  
(JANUARY 1, 2018 – DECEMBER 31, 2018)

**WHEREAS**, Section 8 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994," grants the Technical Education and Skills Development Authority (TESDA) Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts subject to existing laws, rules and regulations;

**WHEREAS**, in the exercise of this power, the TESDA Board shall approve all contracts entered into by the TESDA;

**WHEREAS**, the Finance Committee recommended the award of the contract to D' Triumph Cleaners and Allied Services, Inc. for the Provision of Janitorial Services Requirements for TESDA Central Office (January 1, 2018 – December 31, 2018) during the 99<sup>th</sup> Finance Committee meeting held last 14 December 2017. A copy of its Resolution No. 2017-08 issued on 14 December 2017 is hereto attached as Annex "A" and made an integral part hereof;

**WHEREAS**, in the 103<sup>rd</sup> EXCOM- TESDA Board Meeting held last 18 December 2017 at 10:00 a.m., the members of the TESDA Board favorably endorsed to the TESDA Board the recommendation by the Finance Committee awarding the contract to D' Triumph Cleaners and Allied Services, Inc. for the Provision of Janitorial Services Requirements for TESDA Central Office (January 1, 2018 – December 31, 2018);

**WHEREAS**, to facilitate the immediate implementation of the procurement of goods such as janitorial services, the Procuring Entity, in this case which is TESDA, may undertake the procurement activities short of award. However, no award of contract shall be made until the General Appropriations Act (GAA) for FY 2018 is approved or enacted. Hence, the award of contract shall only be made upon approval of the GAA for FY 2018;


