APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR BAMBOO PRODUCTION NC II

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 20th Direction Setting (DS) Committee, TESDA Board-TESDA Secretariat Consultation Meeting on 17 August 2015, the body favorably endorsed for consideration and approval of the TESDA Board the prioritization of the qualifications for Bamboo Production;

WHEREAS, during the 92nd TESDA Board Meeting on 16 December 2015, the TESDA Board approved the prioritization for training regulations development which consist of the following competencies along bamboo production: operating bamboo nursery, establishing bamboo farm, conducting bamboo clump rehabilitation and conducting bamboo harvesting and post-harvesting;

WHEREAS, industry experts and partners, headed by the Philippine Bamboo Foundation, Inc. with the assistance of the Qualifications and Standards Office (QSO) of TESDA, have developed and endorsed the same for TESDA Board approval and the following organizations have validated the same: Lubao Bamboo Hub, Ed's Farm Inc., Private Bamboo Nursery, Cabaluyan Bamboo, Bamboo Network of the Philippines, Rey Millan Farm and Germinants Farm;

WHEREAS, during the 28th Standards-Setting and Systems Development (SSSD) Committee TESDA Board-TESDA Secretariat Meeting held on November 28, 2017, the Committee favorably endorsed the promulgation of the abovementioned Training Regulations for Bamboo Production NC II;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 18 December 2017 at 2:00 p.m., approves and promulgates the aforementioned Training Regulations for Bamboo Production NC II as herein appended;

- (2) All programs to be registered under these new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The one-year period of registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/ TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and
- (3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.
