**AUTHORIZING THE TESDA REGIONAL DIRECTORS OF REGION VII AND VIII AS OFFICIALLY RECOMMENDED BY THE TESDA DIRECTOR GENERAL TO ENTER INTO AND EXECUTE A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE TESDA BOARD WITH THEIR DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) COUNTERPARTS FOR THE RELEASE AND TRANSFER OF FUNDS IN THE AMOUNT OF FORTY MILLION PESOS (PHP40,000,000.00) FROM TESDA REGION VIII TO THE ACCOUNT OF DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), REGION VIII FOR THE CONSTRUCTION OF INNOVATION CENTER IN BALICUATRO COLLEGE OF ARTS AND TRADES (BCAT), ALLEN, NORTHERN SAMAR, AND IN THE AMOUNT OF TWENTY MILLION PESOS (PHP20,000,000.00) FROM TESDA REGION VII TO THE ACCOUNT OF DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), REGION VII FOR THE CONSTRUCTION OF INNOVATION CENTERS IN REGIONAL TRAINING CENTER, CEBU RESPECTIVELY BOTH SUBJECT TO LIMITATIONS AS MAY BE PROVIDED BY LAW**

**WHEREAS**, there is an existing appropriation in the amount of Forty Million Pesos (Php40,000,000.00) for the Construction of Innovation Center in Balicuatro College of Arts and Trades (BCAT), Allen, Northern Samar under the Regular Agency Fund, FY 2017 General Appropriations Act Republic Act (RA) 10924 Specific Budgets of National Government Agencies;

**WHEREAS**, there is also an existing appropriation in the amount of Twenty Million Pesos (Php20,000,000.00) for the Construction of Innovation Center in TESDA Technology Institutions (TTIs) in Region VII under the Regular Agency Fund, FY 2017 General Appropriations Act, Contingent Fund;

**WHEREAS**, TESDA does not have the proficiency or the capability to undertake these particular procurements;

**WHEREAS**, pursuant to Section 7.3.3 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, in order to hasten project implementation, Procuring Entities which may not have the proficiency or capability to undertake a particular procurement, as determined by the Head of Procuring Entity concerned, may outsource the procurement tasks by requesting other GoP



agencies to undertake such procurement for them, through the execution of a Memorandum of Agreement (MOA) containing specific arrangements and stipulations in accordance with existing government budgeting, accounting and auditing rules;

**WHEREAS**, TESDA recognizes that DPWH Region VII and Region VIII have the administrative and technical capabilities to construct the TESDA Innovation Centers in Region VII and Region VIII respectively and in connection thereto sought their assistance for the said purpose;

**WHEREAS**, the TESDA Director General through a Memorandum dated 22 December 2017 requested the delegation of authority to the Regional Director of Region VII and VIII to enter into a Memorandum of Agreement (MOA) with their respective counterparts in the Department of Public Works and Highway (DPWH); (Annex A)

**WHEREAS**, the amount of Forty Million Pesos (Php40,000,000.00) and Twenty Million Pesos (Php20,000,000.00) respectively will be transferred to DPWH Region VII and VIII as allocations for the aforementioned construction projects;

**WHEREAS**, Region VII and VIII of TESDA and DPWH agreed, subject to the limitations as may be prescribed by law in the utilization, documentation and liquidation of the said amount as well as in the project implementation, monitoring and evaluation thereof in accordance with the rules and regulations embodied in the COA Circular No. 94-2013, Item 3.0 of COA Circular No. 2012-001 and COA Circular No. 2016-002 dated December 13, 1994, June 14, 2014 and May 31, 2016 respectively;

**WHEREAS**, the amount of Forty Million Pesos (Php40,000,000.00) for Region VIII and Twenty Million Pesos (Php20,000,000.00) for Region VII respectively, are existing appropriations that are specifically earmarked for the Construction of Innovation Centers in Balicuatro College of Arts and Trades (BCAT), Allen, Northern Samar and in TESDA Technology Institutions (TTIs) in Region VII under the Regular Agency Fund, FY 2017 General Appropriations Act Republic Act (RA) 10924 Specific Budgets of National Government Agencies and Contingent Fund;

**NOW THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED**, to authorize the TESDA Regional Directors of Region VII and VIII as officially requested by the TESDA Director General to enter into a Memorandum of Agreement (MOA) for and in behalf of the TESDA Board with their Department of Public Works and Highways (DPWH) counterparts for the release and transfer of funds in the amount of Forty Million Pesos (Php40,000,000.00) from TESDA Region VIII and Twenty Million Pesos (Php20,000,000.00) from TESDA Region VII to the account of



Department of Public Works and Highways (DPWH) Region VII and Region VIII respectively for the construction of innovation centers in the aforementioned regions.


**BE IT RESOLVED FINALLY**, that a copy of this Resolution be disseminated to all parties concerned.
