WHEREAS, the TAP and the TEP are vital partners of TESDA in advancing technical education and skills development in the country;

WHEREAS, TESDA Board Resolution No. 2000-01, "Adopting and Implementing the Increase in Honoraria for the TESDA Board, TESDCs and TAPs/TEPs Members" is the policy followed by the agency for the honoraria of the TESDCs and TAPs/TEPs Member, which remained unchanged for the past seventeen (17) years;

WHEREAS, National Budget Circular No. 2007-510 entitled "Guidelines on the Grant of Honoraria to the Governing Boards of Collegial Bodies", issued 8 May 2007, prescribes the guidelines in the grant of honoraria to the governing boards of commissions, boards, councils and other similar entities who are compensated in the form of honoraria as provided by laws.

WHEREAS, the change in the economy due to inflation, which affects the cost of living of an individual in the country shall be considered in the grant of honoraria of consultants and experts from the private sector;
