WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations to effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, TESDA Board Resolution No. 2005-09 was issued approving the prioritization of thirty-five (5) qualification titles for training regulations (TR) development for year 2005 which include the IT (Websites) qualifications last 19 May 2005 during the 46th TESDA Board Meeting;

WHEREAS, TESDA Board Resolution No. 2006-03 was issued approving the prioritization of sixty-two (62) qualification for the development of training regulations (TR) for year 2006 which include the ICT (IT) Websites NC IV qualification last 31 January 2006 during the Special TESDA Board Meeting;

WHEREAS, the Animation Council of the Philippines, Inc. (ACPI) in coordination with the Philippine Software Industry Association (PSIA) initiated the development of the training regulations (TRs) for Web Development NC III in 2016 to align its content with the most recent global standards;

WHEREAS, the scope of work of the new TRs involves development of websites for hosting via intranet or Internet which includes competencies in utilizing software methodologies, developing responsive web design, creating interactive websites and developing website backend systems and hence would be aligned at National Certificate Level III in the Philippine Qualification Framework;

WHEREAS, during the 99th Standards-Setting and Systems Development (SSSD) Committee Meeting held on 12 February 2018, the Committee deliberated upon and favorably recommended to the TESDA Board the promulgation of the abovementioned Training Regulations for Web Development NC III;

WHEREAS, during the 101st TESDA Board Meeting on 27 February 2018 at 1:00 p.m., the TESDA Board considered and approved the promulgation of the Training Regulations for Web Development NC III;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 27 February 2018 at 1:00 p.m., approves and promulgates the aforementioned Training Regulations for Web Development NC III;

BE IT RESOLVED, FINALLY, that copies of the Resolution and the abovementioned Training Regulations be published and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication.

All programs to be registered under this new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The one-year period of registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat.

Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.
