APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR TRAINERS METHODOLOGY LEVEL I (IN-COMPANY TRAINER)

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 22nd Direction Setting (DS) Committee, TESDA Board-TESDA Secretariat Consultation Meeting on 15 February 2016, the body favorably endorsed for consideration and approval of the TESDA Board the prioritization of the qualifications for In-company Trainers;

WHEREAS, during the 93rd TESDA Board Meeting on 30 March 2016, the TESDA Board approved the prioritization for training regulations development of Qualifications along In-company Trainers which include the job of In-company trainer, Training officer, Industry trainer, Training and development officer, workplace trainer and Technology specialist;

WHEREAS, industry experts and partners, headed by Mr. George T. Barcelon, president of Philippine Chamber of Commerce and Industry (PCCI), with the assistance of the Qualifications and Standards Office (QSO) of TESDA, have developed and endorsed the same for TESDA Board approval and the following organizations have validated the same: Foreign Buyers Association of the Philippines (FOBAP), Asian Solidarity Economy Council (ASEC), Production and Operations Management Association of the Philippines (PROMAP), Mactan Rock Ind., Inc., Banilad Center for Professional Development (BCPD), Center for Industrial Technology and Enterprise (CITE), Primary Structures Educational Foundation, Inc. (PSEFI), AFOS – K to 12 Plus Project, MASS-SPECC (Mindanao Association of FIs and Coops) Cooperative Development Center, Peoples Credit and Finance Corporation and FDE STE, Mindanao Trainer, Peoples Credit and Finance Corporation, South Luzon and South Mindanao trainer, Savings Banks Foundation for International Cooperation, South Luzon Microfinance Council and FDE STE, Ahon sa Hirap, Inc.;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 27 February 2018 at 1:00 p.m., approves and promulgates the aforementioned Training Regulations for Trainers Methodology Level I (In-company Trainer) as herein appended;

BE IT RESOLVED, FINALLY, that

- (1) Copies of this Resolution and the abovementioned Training Regulations be published and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication;
- (2) All programs to be registered under these new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The one-year period of registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and
- (3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.
