**APPROVING THE NATIONAL TECHNICAL EDUCATION AND SKILLS
DEVELOPMENT PLAN (NTESDP) 2018-2022**

WHEREAS, Section 21 of Republic Act No. 7796 otherwise known as "TESDA Act of 1994" and Rule II Section 1 of its Implementing Rules and Regulations state that *"The Technical Education and Skills Development Authority (TESDA) shall formulate a comprehensive development plan for middle-level manpower based on a national employment plan or policies for the optimum allocation, development and utilization of skilled workers for employment, entrepreneurship and technology development for economic and social growth, to be known as the National Technical Education and Skills Development Plan (NTESDP)";*

WHEREAS, Section 8 (1) of the TESDA Act of 1994 mandates the TESDA Board to promulgate, after due consultation with industry associations, employers, workers, policies, plans, programs and guidelines, as may be necessary, for the efficient implementation of the Act;

WHEREAS, Section 8 of Republic Act No. 7796 states that the Authority shall primarily be responsible for monitoring and coordinating the implementation of the national technical education and skills development plan and allocate resources necessary to achieve its goals and targets;

WHEREAS, pursuant to President Duterte's "10-Point Socio-Economic Agenda," the TESDA will lead the formulation of the National Technical Education and Skills Development Plan (NTESDP) 2018-2022, which was anchored on the national goals and priorities enunciated in the Philippine Development Plan (PDP) 2018-2022 and the *"Ambisyon Natin 2040";*

WHEREAS, the Fourth Cycle NTESDP anchored on the success of the previous NTESDPs and highlights the envisioned contributions of technical vocational education and training (TVET) to the national development's thrust of accelerating human capital development by ensuring lifelong learning opportunities for all towards Decent Work and Sustainable Inclusive Growth;

**APPROVING THE NATIONAL TECHNICAL EDUCATION AND SKILLS
DEVELOPMENT PLAN (NTESDP) 2018-2022**

WHEREAS, the NTESDP 2018-2022 having the theme "*Vibrant Quality TVET for Decent Work and Sustainable Inclusive Growth*," discusses the TVET's contribution relative to the whole education and training system and its critical role in the overall national development process;

WHEREAS, the NTESDP considers the inputs from the Regional and Provincial Technical Education and Skills Development Plans (R/PTESDPs);

WHEREAS, the NTESDP shall serve as guide and reference of TVET actors and stakeholders in the implementation of TVET programs in the country;

WHEREAS, a series of inter-agency and sectoral consultations and meetings with representatives from government agencies, industry/ employer associations, TVI associations and labor groups nationwide were conducted in the formulation of the NTESDP. It was also presented to the NEDA Social Development Committee (SDC) National-Regional Consultative Meeting on April 18, 2018 and was favorably endorsed for approval by the SDC Cabinet Level;

WHEREAS, the NTESDP 2018-2022 was presented to the TESDA Board-Direction Setting Committee (TB-DSC) on April 5, 2018 wherein the latter, endorsed the plan for further review and approval of the TESDA Board-Executive Committee (TB-ExCom);

WHEREAS, during the 105th TESDA Board-Executive Committee (TB-ExCom) Meeting held on April 23, 2018 and 102nd TESDA Board Meeting on April 25, 2018, the aforementioned NTESDP 2018-2022 plan document was deliberated and favorably endorsed for approval;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED that the TESDA Board in its meeting today, April 25, 2018 at the 7th Floor, TESDA Board Room, approves the National Technical Education and Skills Development Plan (NTESDP), 2018-2022;


