AUTHORIZING THE DIRECTOR GENERAL OF TESDA TO ACCEPT AND SIGN THE DEED OF DONATION INVOLVING TWO THOUSAND NINE HUNDRED SIXTY EIGHT (2,968) SQUARE METERS LOT BY MUNICIPAL GOVERNMENT OF PLARIDEL, MISAMIS OCCIDENTAL DULY REPRESENTED BY ENGR. DIEGO C. TY, MUNICIPAL MAYOR

WHEREAS, Resolution No. 13-2018 adopted by the Sangguniang Bayan of the Municipality of Plaridel, Misamis Occidental authorizes its Municipal Mayor to sign for and on behalf of the local government unit of Plaridel for the donation of a lot with an area of Two Thousand Nine Hundred Sixty Eight (2,968) Square Meters, situated at Panalsalan, Plaridel, Misamis Occidental.

WHEREAS, the subject property is being used by the TESDA X Misamis Occidental Province as Provincial Training Center under usufruct;

WHEREAS, acceptance of the donation is advantageous to TESDA to ensure continuity of the delivery of TVET services in the Province;

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations.

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority;

WHEREAS, the Administrative Code provides that in conveyances of property it has to be the Head of the Agency who will sign the Deed of Donation subject to the approval of the Board;

WHEREAS, both the Executive Committee and Finance Committee favorably endorsed to the Board the grant of authority for the TESDA Director General to accept and sign the Deed of Donation involving Two Thousand Nine Hundred Sixty Eight (2,968) square meters lot with the Municipal Government of Plaridel, Misamis Occidental duly represented by Engr. Diego C. Ty, Municipal Mayor;


