**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR  
PRESSURIZED IRRIGATION SYSTEM INSTALLATION AND MAINTENANCE  
NCII**

**WHEREAS**, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

**WHEREAS**, the **Agricultural Machinery Manufacturers and Distributors Association (AMMDA)** in collaboration with the Department of Agriculture (DA), is the lead industry organization in the Agriculture, Forestry and Fishery (AFF) Sector and known provider of the expertise needed for the industry;

**WHEREAS**, Agricultural Machinery Manufacturers and Distributors Association (AMMDA) in collaboration with the Department of Agriculture (DA), with the assistance of Qualifications and Standards Office (QSO) of TESDA has developed the Training Regulations in Pressurized Irrigation System Installation and Maintenance NCII for Agriculture, Forestry and Fishery (AFF) Sector;

**WHEREAS**, the Agricultural Machinery Manufacturers and Distributors Association (AMMDA) initiated the development of the Training Regulations (TRs) for Pressurized Irrigation System Installation and Maintenance NCII with the assistance of Qualifications and Standards Office (QSO);

**WHEREAS**, the scope of work of the new TRs for Pressurized Irrigation System Installation and Maintenance NCII involves to perform installation of pumps and control devices, perform installation of pipeline and water distribution devices and perform maintenance of pressurized irrigation system;

**WHEREAS**, industry experts and partners, headed by the President of the Agricultural Machinery Manufacturers and Distributors Association (AMMDA), with the technical assistance of the Qualifications and Standards Office (QSO) of TESDA have developed and endorsed the same for TESDA Board Approval;

**WHEREAS**, during the 107<sup>th</sup> TESDA Board Meeting on 11 January 2019 at 9:00 a.m., the TESDA Board considered and approved the promulgation of the Training Regulations for Pressurized Irrigation System Installation and Maintenance NCII;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, that the TESDA Board in its meeting today, 11 January 2019 at 9:00 a.m., approves and promulgates the aforementioned Training Regulations for Pressurized Irrigation System Installation and Maintenance NCII as herein appended;

(1) Copies of this Resolution and the abovementioned Training Regulations be published in the Official Gazette and one (1) newspaper of general circulation, and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication;

(2) All programs to be registered under these new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/ TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and






