**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
WAREHOUSING SERVICES NC III**

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the Supply Chain Management Association of the Philippines (SCMAP) is the lead industry organization in the Logistics and Transport Sector and known provider of the expertise needed for the industry;

WHEREAS, the Supply Chain Management Association of the Philippines (SCMAP) initiated the development of the Training Regulations (TR) for Warehousing Servicing NC III with the assistance of Qualifications and Standards Office (QSO);



WHEREAS, the scope of work of the new TR for Warehousing Services NC III involves completing receipt/dispatch documentation, identifying and inspecting stored stocks, maintaining transport/stock records, participating in stock inventory count and rendering excellent customer service;

WHEREAS, industry experts and partners, headed by the President of Supply Chain Management Association of the Philippines (SCMAP), with the technical assistance of the Qualifications and Standards Office (QSO) of TESDA have developed and endorsed the same for TESDA Board Approval;

WHEREAS, during the 115th Standards-Setting and Systems Development (SSSD) Committee Meeting held on 03 December 2019, the Committee deliberated upon and favorably recommended to the TESDA Board the promulgation of the Training Regulations for Warehousing Services NC III;

WHEREAS, during the 118th TESDA Board Meeting on 17 December 2019 at 9:00 a.m., the TESDA Board considered and approved the promulgation of the Training Regulations for Warehousing Services NC III;

The registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/ TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and


(3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.


(4) Copy of the Training Regulations is hereby made an integral part of this Resolution.
