**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
SPEED LIMITATION DEVICE SERVICING NC II**

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the Department of Transportation (DOTr) is the lead national government agency under the Automotive and Land Transport Sector and known provider of the expertise needed for the industry;

WHEREAS, the Department of Transportation (DOTr) initiated the development of the Training Regulations (TR) for Speed Limitation Device Servicing NC II with the assistance of Qualifications and Standards Office (QSO);

WHEREAS, the scope of the work of the new TR for Speed Limitation Device Servicing NC II involves the conduct of basic inspection of engine and other electrical components; installation, repair, and maintenance of Speed Limitation Device. It covers both manufactured and second-hand vehicles, closed van, covered vehicle, hauler or cargo truck, motor vehicle, public utility vehicle (PUV), shuttle service, and tanker truck;

WHEREAS, the industry experts and partners, headed by the Secretary of the Department of Transportation (DOTr), President of Truck Manufacturers Association (TMA), and President of Chamber of Automotive Manufacturers of the Philippines, Inc. (CAMPI) with the technical assistance of the Qualifications and Standards Office (QSO) of TESDA have developed and endorsed the same for TESDA Board Approval;

WHEREAS, during the 123rd Standards-Setting and Systems Development (SSSD) Committee Meeting held on 25 June 2020, the Committee deliberated upon and favorably recommended to the TESDA Board the promulgation of the Training Regulations for Speed Limitation Device Servicing NC II;

WHEREAS, during the 122nd TESDA Board Meeting on 11 August 2020, the TESDA Board deliberated and considered the proposed Training Regulations for Speed Limitation Device Servicing NC II;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the aforementioned Training Regulations for Speed Limitation Device Servicing NC II as herein appended is hereby approved and promulgated;

BE IT RESOLVED, FINALLY, that:

(1) Copies of this Resolution and the abovementioned Training Regulations be published in the Official Gazette or in a newspaper of general circulation, and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication;

(2) All programs to be registered under this new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/ TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and

(3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.


