APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR BEEKEEPING NC II

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the Department of Agriculture (DA) as the lead national government agency under the Agriculture, Fishery and Forestry Sector in partnership with University of the Philippines – Los Baños (UPLB) and Flor Apiary known provider of the expertise needed for the industry;

WHEREAS, the University of the Philippines – Los Baños (UPLB) together with Flor Apiary initiated the development of the Training Regulations (TR) for Beekeeping NC II with the assistance of Qualifications and Standards Office (QSO);

WHEREAS, the scope of the work of the new TR for Beekeeping NC II involves the establishment of hived colonies in a bee yard, manage bee colonies, propagate bee colonies, conduct harvesting operations, and provide bee pollination services. It also covers handling different species of bees including domesticated and wild species. Harvesting activities end until extraction of raw honey. Application of health and safety measures is required in performing every task:

WHEREAS, the industry experts and partners, headed by the Chancellor of the University of the Philippines – Los Baños (UPLB) and manager of Flor Apiary, with the technical assistance of the Qualifications and Standards Office (QSO) of TESDA have developed and endorsed the same for TESDA Board Approval;

WHEREAS, during the 125th Standards-Setting and Systems Development (SSSD) Committee Meeting held on 03 August 2020, the Committee deliberated upon and favorably recommended to the TESDA Board the promulgation of the Training Regulations for Beekeeping NC II;

WHEREAS, during the 122nd TESDA Board Meeting on 11 August 2020, the TESDA Board deliberated and considered the proposed Training Regulations for Beekeeping NC II;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the aforementioned Training Regulations for Beekeeping NC II as herein appended is hereby approved and promulgated;

BE IT RESOLVED, FINALLY, that:

- (1) Copies of this Resolution and the abovementioned Training Regulations be published in the Official Gazette or in a newspaper of general circulation, and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication;
- (2) All programs to be registered under this new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/ TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and
- (3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.
