#### APPROVING THE AMENDMENT OF THE TRAINEE ENTRY REQUIREMENTS FOR DRIVING NC II

WHEREAS, TESDA Board Resolution No. 2004-20 was issued "Approving and Promulgating the Training Regulations for Driving NC II" last 09 December 2004 during the 44<sup>th</sup> TESDA Board Meeting;

WHEREAS, Section 4. on the Mandatory Theoretical Driving Course of Memorandum Circular No. 2019-2176 on the "Rules and Regulations on Accreditation, Supervision and Control of Driving Institutions, and on Standardization of Driver Education" issued by the Land Transportation Office (LTO) provides that student-driver's permit shall only be issued upon completion of a mandatory theoretical driving course to be conducted by the LTO or its duly accredited driving school for at least fifteen (15) hours and shall be completed within two (2) years from the start of the course;

**WHEREAS**, during the 125<sup>th</sup> Standards-Setting and Systems Development (SSSD) Committee Meeting held on 03 August 2020, the Committee recommended to consult with the LTO on the requirement of the applicants for student-driver's permit to complete the fifteen (15) hour-theoretical driving course;

WHEREAS, the Qualifications and Standards Office (QSO) held an online consultation meeting with the LTO on 27 August 2020 to discuss the possible collaboration of TESDA with said office to enhance the modules of the 15-Hour Theoretical Driving Course and harmonize the same with the Training Regulations for Driving NC II;

WHEREAS, during the online consultation meeting with the LTO, it was made clear that all trainees and candidates for assessment of Driving NC II must be holders of any driver's license before they could operate any motor vehicle. This is pursuant to Republic Act No. 4136, otherwise known as the Land Transportation and Traffic Code, particularly Section 19 thereof. Thus:

**Section 19.** *Duty to procure license.* - Except as otherwise specifically provided in this Act, no person shall operate any motor vehicle without first procuring a license to drive a motor vehicle for the current year, nor while

such license is delinquent, invalid, suspended or revoked. The license shall be carried by the driver at all times when operating a motor vehicle, and shall be shown and/or surrendered for cause and upon demand to any person with authority under this Act to confiscate the same.

**WHEREAS**, in view of this requirement of the law, the following Trainee Entry Requirements are now being proposed for adoption:
