PRIORITIZATION OF COMMUNITY NUTRITION SERVICES FOR TRAINING REGULATIONS (TR) DEVELOPMENT

WHEREAS, Item (B), Section 14 of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system, of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, TESDA shall focus its efforts and resources on priority qualifications/skills identified by partner-industry bodies and associations on the basis of the following:

- 1. Priority needs of the industry-sector;
- 2. Nationwide application in terms of public interest/welfare:
- 3. Employment generation and investment opportunities; and
- 4. The criteria for skills standardization and certification, to wit:
 - Requiring relatively long period of education or training:
 - Performance of the competency affecting and endangering people's lives and limbs; and
 - Competency involving the handling of complex equipment, tools and supplies.

WHEREAS, in addition to the abovementioned criteria, support for the development of skills/qualifications shall also be prioritized based on existing laws of the sector/industry governing the promotion on the competitiveness and promoting Filipino workers and the development thrusts of the government, among others;

WHEREAS, malnutrition remains to be a public health concern in the Philippines wherein most affected are children below five years old and pregnant women that if not addressed will later produce a labor force with reduced physical and mental capacities and productivity;

WHEREAS, the National Nutrition Council Governing Board recognizes the need to address current malnutrition situation of the country, which led to the formulation of NNC Governing Board Resolution No. 6 s. 2019. This includes provision on the development of Training Regulations that will standardize the competence of workforce for the Community Nutrition Services;
