**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
CONTACT TRACING NC II**

WHEREAS, Section 14 (b) of Republic Act No. 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the Department of Health is the lead national government agency under the Human Health/Health Care Sector and known provider of the expertise needed for the industry;

WHEREAS, the Department of Health - Health Human Resource Development Bureau initiated the development of the Training Regulations (TR) for Contact Tracing NC II with the assistance of Qualifications and Standards Office (QSO);

WHEREAS, the scope of the work of the new TR for Contact Tracing NC II involves to conduct case investigation and contact identification, conduct profiling of contacts and follow-up, conduct referral to health facility, quarantine facility, and other relevant agencies, conduct health education programs, perform data recording and reporting and conduct monitoring and surveillance for all notifiable diseases;

WHEREAS, the industry experts and partners, headed by the Health Human Resource Development Bureau of the Department of Health and the technical experts from the Baguio City Epidemiology Surveillance Unit, Contact Tracing and Monitoring Team, City Camp Health District of Baguio City and Municipality of Unisan, Quezon with the technical assistance of the Qualifications and Standards Office (QSO) of TESDA have developed and endorsed the same for TESDA Board Approval;

WHEREAS, during the 136th Standards-Setting and Systems Development (SSSD) Committee Meeting held on 02 June 2021, the Committee deliberated upon and favorably recommended to the TESDA Board the promulgation of the Training Regulations for Contact Tracing NC II;

**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
CONTACT TRACING NC II**

WHEREAS, during the 130th TESDA Board Meeting on 08 June 2021, the TESDA Board deliberated and considered the proposed Training Regulations for Contact Tracing NC II;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the aforementioned Training Regulations for Contact Tracing NC II as herein appended is hereby approved and promulgated;

BE IT RESOLVED, FINALLY, that:

(1) Copies of this Resolution and the abovementioned Training Regulations be published in the Official Gazette or in a newspaper of general circulation, and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication;

(2) All programs registered under the current Competency Standards for Contact Tracing NC II must comply with the requirements of the aforementioned Training Regulations. The one-year period of re-registration under this Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/ TESDA Circular for the deployment of the Training Regulations to be issued by the TESDA Secretariat; and

(3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.


