WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Educations and Skills Development Authority;

WHEREAS, the TESDA Board during its 120th TESDA Board Meeting issued Board Resolution No. 2020-13 which grants the Director General the authority to accept and sign Deeds of Donation involving parcels of land donated by local government units and other entities on behalf of TESDA, subject to subsequent ratification of the TESDA Board;

WHEREAS, the Local Government of Irosin owns a parcel of land with an area of ten thousand square meters (10,000 sq m) located at Barangay Mapaso, Irosin, Sorsogon covered under Lot No. 3343-B CAD 462-D;

WHEREAS, as an act of liberality and generosity of the Local Government Unit of Irosin, which agreed to donate a parcel of land covered under Lot No. 3343-B CAD 462-D with a total area of ten thousand (10,000) square meters;

WHEREAS, Director General, Sec. Isidro S. Lapeña, PhD, CSEE, on behalf of the TESDA Board accepted and received the donation made in its favor by the Municipal Mayor of Irosin, Hon. Alfredo J. Cielo, Jr., for the establishment of TESDA Hub on the donated property;

WHEREAS, upon consultation with line agencies, Mines and Geosciences Bureau (MGB) of the Department of Environment and Natural Resources (DENR) and the Philippine Institute of Volcanology and Seismology (PHIVOLCS), the following were noted:

- The property is approximately 4.0 kilometer southeast of Bulusan Volcano and is highly susceptible to lahar and lava flow;
- Largely low to moderate susceptible and partly highly susceptible to pyroclastic flow; and
- Partly moderate susceptible to earthquake induced landslide.

WHEREAS, TESDA was forced to request for another site due to the adverse findings and subsequently cancelled the previously executed Deed of Donation;

WHEREAS, the Sangguniang Bayan of the Municipality of Irosin issued Resolution No. 63 series of 2021, dated 26 April 2021 entitled "Resolution to Recall Resolution No. 91(A)-2020, (Resolution Granting Authority to the Local Chief Executive to Enter into A Deed of Absolute Donation with the Technical Education and Skills Development Authority (TESDA) Sorsogon City Represented by Director General Isidro S. Lapeña, PhD, CSEE, for the Utilization of Lot at Barangay Mapaso as a Training Facility).

WHEREAS, by virtue of the authority given by the Sangguniang Bayan of the Municipality of Irosin, the Deed of Cancellation of Donation was signed between Hon. Alfredo J.
