**RATIFICATION OF THE DEED OF DONATION AND ACCEPTANCE SIGNED BY
THE DIRECTOR GENERAL ON BEHALF OF THE TESDA BOARD INVOLVING
PARCEL OF LAND DONATED BY THE PROVINCIAL GOVERNMENT OF DAVAO
ORIENTAL WITH A TOTAL AREA OF 1, 614 SQUARE METERS**

WHEREAS, Section 8 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994," grants the Technical Education and Skills Development Authority (TESDA) Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts subject to existing laws, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Educations and Skills Development Authority;

WHEREAS, the TESDA Board during its 120th TESDA Board Meeting issued Board Resolution No. 2020-13 which grants the Director General the authority to accept and sign Deeds of Donation involving parcels of land donated by local government units and other entities on behalf of TESDA, subject to subsequent ratification of the TESDA Board;

WHEREAS, the Regional Director of TESDA-Regional Office XI, Director Lorenzo G. Macapili initiated efforts to establish a Provincial Training Center in Barangay Dahican, City of Mati;

WHEREAS, the Provincial Government of Davao Oriental owns a parcel of land, Lot 3, containing an area of two hundred eighty-four thousand two hundred twenty-six (284,226) square meters, covered by Transfer Certificate of Title No. 143-2017001700;

WHEREAS, out of the liberality and generosity of Provincial Government of Davao Oriental, they agreed to donate a parcel of land containing one thousand six hundred fourteen (1,614) square meters, a portion of Lot 3, covered by Transfer Certificate of Title No. 143-2017001700;

WHEREAS, on July 20, 2020, the Sangguniang Panlalawigan of the Provincial Government Davao issued Resolution No. 16-479-07-2020 entitled "A Resolution Amending the SP Resolution No. 16-115-11-2019 By Changing the Lot Size from "990 Square Meters" to "1,614 Square Meters", and the Same Shall Now Be Read As
