**WHEREAS**, during its 133<sup>rd</sup> TESDA Board Meeting, the TESDA Board discussed and deliberated on the proposal and agreed to the recommendations of the Ethics and Protocols Committee;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, that the TESDA Board in its meeting today, 09 November 2021, has agreed to repeal Board Resolution No. 2019-39 which provides for the “Reconstitution of the Executive Committee of the TESDA Board” and consequently dissolve the Executive Committee of the TESDA Board;
