FOR AUTOMOTIVE SERVICING NC III TO AUTOMOTIVE DIAGNOSIS
(CHASSIS) NC III, AUTOMOTIVE DIAGNOSIS (ELECTRICAL) NC III AND
AUTOMOTIVE DIAGNOSIS (ENGINE) NC III, AND THE AMENDED TRAINING
REGULATIONS FOR AUTOMOTIVE BODY PAINTING/FINISHING NC III TO
COMPLEX PAINT REFINISHING NC III**


WHEREAS, TESDA Board Resolution No. 2006-09 on "Approving and Promulgating the Training Regulations for Automotive Servicing NC III" was issued last 20 April 2006 during the 49th TESDA Board Meeting;

WHEREAS, TESDA Board Resolution No. 2013-11 was issued "Approving the Amendments of the Training Regulation for Automotive Servicing NC III" last 17 December 2013 during the 87th TESDA Board Meeting;

WHEREAS, TESDA Board Resolution No. 2006-22 was issued "Approving and Promulgating the Training Regulation for Automotive Body Painting/Finishing NC III" last 26 October 2006 during the 52nd TESDA Board Meeting;

WHEREAS, it is the policy of TESDA to review after three (3) years any Training Regulations (TRs) promulgated by the TESDA Board;

WHEREAS, there is a need to review the existing Training Regulations in view of the developments in technology and current trends in the Automotive and Land Transport industry and to align its content with the most recent global standards;

WHEREAS, the Chamber of Automotive Manufactures of the Phils. Inc. (CAMPI), with the assistance of the Qualifications and Standards Office (QSO) of TESDA, has reviewed and recommended to amend the existing Training Regulations for Automotive Servicing NC III and Automotive Body Painting/Finishing NC III to respond to the current skills requirements of the industry with its new technologies and industry manpower set-up and recommended amendments;


WHEREAS, during the 170th Standards Setting and Systems Development (SSSD) Committee Meeting held on 05 August 2024, the Committee further deliberated upon and favorably recommended to the TESDA Board the promulgation of the Automotive Diagnosis (Chassis) NC III (**Annex A**), Automotive Diagnosis (Electrical) NC III (**Annex B**), Automotive Diagnosis (Engine) NC III (**Annex C**), and Complex Paint Refinishing NC III (**Annex D**), under the Automotive and Land Transport Sector;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 13 November 2024 at 1:00 P.M. has approved and promulgated the aforementioned Training Regulations under the Automotive and Land Transportation Sector as herein appended;

BE IT RESOLVED, FINALLY, that:

(1) Copy of this Resolution and the abovementioned Training Regulations be published in the Official Gazette or in a newspaper of general circulation, and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication;

(2) All programs to be registered under this new Training Regulations must comply with the requirements of the aforementioned Training Regulations. The registration under this new Training Regulations shall commence on the date of effectivity as indicated in the Implementing Guidelines/TESDA Circular for the


deployment of the Training Regulations to be issued by the TESDA Secretariat; and


(3) Graduates of TVET programs covered by the aforementioned Training Regulations shall be required to undergo mandatory assessment under the national assessment and certification program.


