SUBJECT : Canteen Service Provider

This refers to the operation of the canteen concessionaire, Pixelito Cuisine, that ended on May 16, 2018.

The Canteen Committee recognizes the immediate need to have food provider/s cater to the requirements of TESDA officials and employees. Hence, it requested the TESDA-ACE, through its president Mr. Renato Geron to find food providers that can offer different meals and other food items at reasonable prices. As there is a provision in the Collective Negotiation Agreement (CNA) that the Union is allowed to engage in income-generating activities, the TESDA-ACE agreed to take charge of operating the canteen utilizing a "Food Court" style.

The proposed arrangement would provide immediate relief to the present difficulty of limited sources of food within the complex, as this approach would not require the Committee to go through the tedious process of selection of a canteen concessionaire. However, there are still some issues that has to be resolved before a final arrangement with the TESDA-ACE can be adopted.

Meanwhile, the Canteen Committee decided to invite other food providers to offer their services as canteen concessionaire following the established selection process. Initially, the Request for Expression of Interest for Concession and Operation of TESDA Administration Building Canteen shall be posted at the TESDA website beginning June 21, 2018.

Rest assured that the Committee is extending all efforts to facilitate the provision of food services to our internal and external clients.
