CONTRACT AGREEMENT FOR THE CONSTRUCTION OF REGIONAL TVET INNOVATION CENTER FOR TESDA CARAGA REGION AT AGUSAN DEL SUR SCHOOL OF ARTS AND TRADES

THIS AGREEMENT made this _____ day of _____ 2024 by and between TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) with principal address at TESDA Complex, East Service Road, South Luzon Expressway, Fort Bonifacio, Taguig City, Metro Manila, Philippines (hereinafter called the "Procuring Entity") of the one part and RCDG CONSTRUCTION CORPORATION/ANZ CONSTRUCTIONS FINISHING SERVICES JOINT VENTURE with business address at A. Ruste Drive, San Jose Claret, Zamboanga City (hereinafter called the "Contractor") of the other part;

WHEREAS, the Procuring Entity is desirous that the Contractor executes the Construction of Regional TVET Innovation Center for TESDA CARAGA Region at Agusan Del Sur School of Arts and Trades (ASSAT) (hereinafter called "the Works") and the Procuring Entity has accepted the Bid for Thirty-Five Million Nine Hundred Eighty Thousand Eighteen Pesos and 62/100 (₱35,980,018.62) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to below.

- Location of the Contract and Completion of the Works:
 Location of the Contract: inside the main campus of ASSAT at ASSAT GDOP, Government Center Prosperidad, Agusan Del Sur

Completion of the Works: Within Two Hundred Forty (240) Calendar Days inclusive of the processing of the building permit upon receipt of Notice to Proceed (NTP)

- 4. In consideration for the sum Thirty-Five Million Nine Hundred Eighty Thousand Eighteen Pesos and 62/100 (₱35,980,018.62) or such other sums as may be ascertained, RCDG CONSTRUCTION CORPORATION/ ANZ CONSTRUCTIONS FINISHING SERVICES JOINT VENTURE agrees for the Construction of Regional TVET Innovation Center for TESDA CARAGA Region at ASSAT.
- 5. Payment in favor of the **CONTRACTOR** shall be made through progress billing based on actual work accomplishment.
- 6. The **PROCURING ENTITY** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
- 7. Any delay in the completion of the work shall be governed by Section 68 (Liquidated Damages) of the Revised Implementing Rules and Regulations of Republic Act No. 9184. For the Infrastructure Projects, the amount of the liquidated damages shall be at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion of everyday of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of contract, the Procuring Entity may rescind or terminate the contract without prejudice to other courses of action and remedies available under the circumstances.
