How will the checklist / compliance (Section VI and VII) be assessed? Do we need to submit a separate vendor-drafted technical SOW document or just a signed section VI and section VII?	Please refer to Item 17- Opening and Preliminary Examination of Bids and Item 19-Detailed Evaluation and Comparison of Bids under Section II-Instructions to Bidders
Which requirements in sections VI and VII need attached proof documents? Just the Section VII. B. Provider Qualification / Requirements?	The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of R.A. 9184.

For Section VII. Technical specifications – Item B. provider qualifications / requirements item No. 7 What are the required supporting documents for this? Will providing the named resources CVs (reflecting required experience) and their relevant diplomas be acceptable?	Any evidence (Certificate) Providing the CVs of named resources and their relevant diplomas is essential, but may not be sufficient on their own. Additional supporting documents such as certificates of employment, professional licenses, diplomas or academic certificates, and professional licenses or certifications (if applicable) may be required to fully demonstrate compliance.
Do we need to sign all the pages of the documents to be submitted or only the part where signature is required?	Yes. All the pages of the documents to be submitted must be duly signed by the bidder's authorized representative.
On the requirement under Section VII.A.1.8.3 "Responsive to any device (desktop, tablet and mobile)" is too broad. Can we request to relax this requirement to add: "specific devices and versions to be supported will be agreed on with TESDA during the project"	Yes.
On the requirement under Section VII.B.1 Provider Qualification Requirements, "Should have at least two (2) years of experience in implementing / Operating RAG (Retrieval Augmented Generation) platforms on at least one (1) large-scale set-up (e.g. 100k+ documents ingested and queryable within the last three (3) years." Of experience in implementing / operating RAG platforms?	Yes.
May we please request to relax the requirement to having just "at least one (1) year	Was a
