Due to the current status of the country brought by the COVID-19 Pandemic the regional targets were amended. Based on the new set regional targets, the data shows that the agency has achieved 29.89% of its target enrollment output while 40.49% for the graduates. Among the regions, the highest accomplishment is accounted in Region XI both for the enrollment and graduates.

It is significant to note that the regional outputs increase from 1st quarter to 2nd quarter in both for the enrollment and graduate, Highest percentage increase in output is recorded in Region VII.

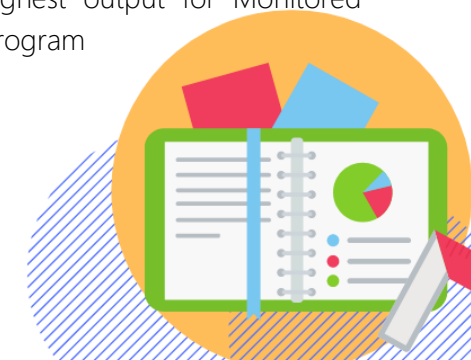

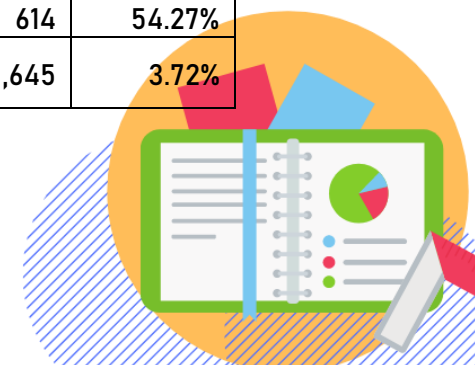

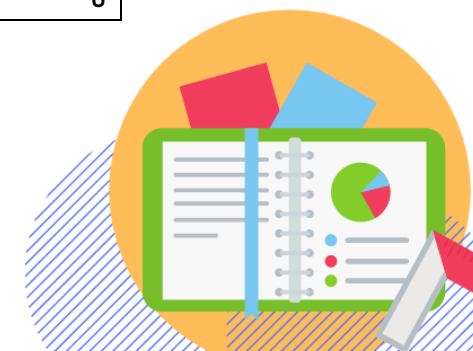
