

## INVITATION TO BID

The Technical Education and Skills Development Authority (TESDA), through the General Appropriations Act for CY 2014, intends to apply the sum of Seven Million Four Hundred Ninety Nine Thousand Nine Hundred Eight One Pesos and 24/100 Only (Php 7,499,981.24) being the Approved Budget for the Contract (ABC), to payment for the procurement of new elevator units for the TESDA Central Office Administration Building. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

TESDA now invites suppliers to apply for eligibility and to bid for the Procurement of New Elevator Units for the TESDA Central Office Administration Building.

Bidders should have at least two (2) completed and/or on-going similar projects within a five (5) year period from the date of bid opening. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II of the Instructions to Bidders.

Bidding will be conducted through public bidding using a non-discretionary "pass/fail" criterion as prescribed by the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act.

A complete set of Bidding Documents may be purchased by interested Bidders beginning on 23 April 2014 from the address written below and upon payment of a non-refundable fee of **Twenty Thousand Pesos only (Php 20,000.00)** for the Bidding Documents.

TESDA will hold a Pre-Bid Conference on **05 May 2014 at 2:00 p.m.** at the AS Conference Room, 2<sup>nd</sup> Floor, TESDA Administration Building, Taguig City, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be submitted to the BAC Secretariat, AS Conference Room, 2<sup>nd</sup> Floor, TESDA Administration Building, Taguig City on or before **22 May 2014 at 2:00 p.m**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Clause 18 of Instructions to Bidders.

Bid opening shall be held on **22 May 2014 at 2:15 p.m.** at the AS Conference Room, 2<sup>nd</sup> Floor, TESDA Administration Building, Taguig City where the bids will be opened in the presence of the Bidders' representatives. Late bids shall not be accepted.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act No. 9184 and its Revised Implementing Rules and Regulations.

TESDA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders.

TESDA assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
