INVITATION TO BID

The Technical Education and Skills Development Authority (TESDA), through the General Appropriations Act for CY 2014, intends to apply the sum of Three Hundred Forty Six Million Seventy Two Thousand Three Hundred Five Pesos and Sixty Two Centavos Only (Php 346, 072, 305.62) being the Approved Budget for the Contract (ABC), to payment for the procurement of starter toolkits for the target beneficiaries of the Special Training for Employment Program (STEP). Bids received in excess of the ABC shall be automatically rejected at the bid opening.

TESDA now invites suppliers to apply for eligibility and to bid for the procurement of starter toolkits for the target beneficiaries of the Special Training for Employment Program (STEP).

Bidders should have at least two (2) completed and/or on-going similar projects within a five (5) year period from the date of bid opening. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II of the Instructions to Bidders.

Bidding will be conducted through public bidding using a non-discretionary "pass/fail" criterion as prescribed by the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act.

A complete set of Bidding Documents may be purchased by interested Bidders beginning on 16 July 2014 from the address written below and upon payment of a non-refundable fee of Ninety Five Thousand Pesos Only (Php 95,000.00) for the Bidding Documents.

TESDA will hold a Pre-Bid Conference on **30 July 2014 at 2:00 p.m.** at the CSA Conference Room, 2nd Floor, TESDA Administration Building, Taguig City, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be submitted to the BAC Secretariat, CSA Conference Room, 2nd Floor, TESDA Administration Building, Taguig City on or before **19 August 2014 at 2:00 p.m**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Clause 18 of Instructions to Bidders.

Bid opening shall be held on 19 August 2014 at 2:15 p.m. at the CSA Conference Room, 2nd Floor, TESDA Administration Building, Taguig City where the bids will be opened in the presence of the Bidders' representatives. Late bids shall not be accepted.
